The collection of general information

When you access our website, information of a general nature is automatically collected. Cookies

Like many other websites, we also use "cookies". Cookies are small text files that are transferred to your hard drive by a website server. We thereby automatically receive certain data, such as your IP address, browser used, operating system via your computer and your connection to the internet.

Cookies cannot be used to launch programmes or to transfer viruses to a computer. Based on the information contained in cookies, we can facilitate navigation and enable our web pages to be displayed correctly.

Under no circumstances will the data that we collect be passed on to third parties or any link to your personal data be established without your consent.

You can, of course, always view our website without cookies. The settings on internet browsers are routinely adjusted so as to accept cookies. You can disable cookies at any time by changing your browser settings. Please use the help functions of your internet browser to find out how to change these settings. Please note that if you do disable the use of cookies, some of the functions of our website may not work or may only work to a limited extent.

SSL encryption

In order to protect the security of your data during transmission, we use state-of-the-art encryption methods (e.g. SSL) via HTTPS for subsections of the web pages. Web pages that are assigned to the "process technology" business area are currently not yet transmitted in an encrypted form.

Your rights of access, rectification, locking, erasure and objection
